To our community,

We would like to take time to discuss and acknowledge the concerns you may have regarding COVID-19 and the impact on Golden State Fur Con 2020. We want to provide transparency and give answers regarding the various aspects of the plan going forward. First of all we believe in the Fandom and our Attendees and have things put in place to make the transition to the new dates as seamless as possible.

As you may know, we have decided to postpone the convention due to the COVID-19 outbreak. We have worked with both the hotel and local government and have been constantly monitoring the news and CDC releases and have decided to postpone the convention to a later date instead of canceling. We believe in the safety and well-being of every single attendee.

**The new dates for Golden State Fur Con are August 28th-30th 2020.**

**Question: What about my registration?**

Our team believes in giving you the most flexibility regarding your registration for the new dates. Our team will migrate your current registration, of any tier, to the new date automatically. If desired you may also opt to have your registration transferred to GSFC 2021 taking place April 9th-11th, 2021, or to another Corgi Event LLC convention. However, if you are not able to attend GSFC on August 28th-30th, April 9th-11th 2021 or another Corgi Event LLC con, you may opt to have your registration refunded. In addition to the changes in dates, we will be adjusting our registration tier dates to reflect previous dates accordingly, should you wish to register for the August 2020 GSFC. Sponsor tiers and above will receive their swag for the year they attend.
